Dear members,

The calendar for this year also looks great. The DDI is growing. There are now the first judge training courses in Spain and we have a candidate judge from Greece. We have uploaded a judging table to our homepage, which every organiser can use. We hope that this will also make the uploaded scoring tables more clear and easier to read. If you have any questions, please contact us.

Ideas included, for example, making it easier for members to enter tournaments, better communication of dates and entry times, a Facebook group for members only and discounts for members. The judging committee has already held 3 meetings in 2024, where, among other things, the new regulations regarding HTM and the handling of aggressive dogs were discussed and worked out.

There are many other topics under discussion in the committee, some of which will be incorporated into the regulations as changes to the wording in order to minimise potential comprehension problems. Others will be submitted as motions to the AGM. Specific questions will also be answered directly after discussion in the committee. Furthermore, important information from the committee will in future be passed on directly to the active judges or published as information to the members via the DDI newsletter.

Questions from members and active judges can still be sent directly to the committee or to the committee via the Executive Board.

Thank you to all members of the judges' board for your commitment, your ideas and also for writing the minutes, which are available for inspection by both the judges' board and the Executive Board.

Jessica Lang also organised and moderated the monthly judges' discussion rounds in 2023 and the discussion rounds were actively used by the active judges. I would like to take this opportunity to thank her for her commitment and wish her all the best for the new phase of her life (with the hopefully upcoming dogdance offspring)! The judge training programme has been strengthened and the judge trainers have already met via Zoom in 2024 to discuss the upcoming workshops and questions relating to judge training. Together with the judges' committee, we have worked out the structure of the judges' training and further training for the coming year. This is as follows.

#### Procedure for judge training:

- 1. become a member of the DDI
- 2. register for the judge training (plus payment of the complete training costs)
- 3. participation in 3 online judge training evenings (held by Claudia Moser)
- 4. participation in a full-day live judges' workshop (held by the trainers from the individual countries)
- 5. assignment of judge coach to assist with questions
- 6. shadow judging assignments\*
- 7. final meeting with judge coach and approval as a judge by the DDI
- \* A solution is currently being worked out with the judge trainers to be able to offer the possibility of online shadow judging for judges from new DDI countries with no or hardly any tournaments.

#### Expiry of further training for judges from 2025:

The interval for further training is 2 years. After attaining judge status, the judge receives their judge certificate. The further training interval starts on 1 January of the following year and ends on 31 December of the second year.

Further training is mandatory:

- 2 online discussion rounds per year\*
- Participation in one 3-hour online training course per year \*
- In 2 years either 2 judging assignments (at least 1 assignment at an official tournament with judging of official classes)

- Or (if not enough judging assignments) participation in a full-day live judging workshop

Judges are obliged to keep track of their further training independently and to submit this to the judge administration for checking at the end of their further training interval and to confirm that they wish to be listed as an active judge for a further 2-year interval.

Once all the required evidence has been provided, the judge will receive their new judge certificate, which confirms the validity and duration of their judge status.

Last year, 2 online judge training courses (with Claudia Moser), 1 online advanced training course (with Claudia Moser) and 3 live workshops took place (D - Katharina Henf, CH - Claudia Moser, I - Fruszi Willheim).

I am very pleased that we were able to welcome a whole group of new judges from Spain and Portugal for the first time this year. There will be a first DDI tournament in Spain in October, which will be combined with a live judging workshop and the first shadow judging assignments.

And this year there have already been 2 online training evenings (held by Claudia Moser), as well as 2 live training sessions in Germany (held by Katharina Henf) and Italy (held by Barbara Cristallini). In Hungary, there was also a first round of discussions and an update workshop to bring the judges up to date.

Further workshops for prospective judges and further training workshops are planned.

Another thank you goes to the helpers in the background, who have the now very extensive administration under control and bring order to the complex chaos! Thanks to Sandra Schneider and Annette Krunic, without you the judging system would not work! Manuela Galka will also be supporting the admin team this year, thank you for your help.

And last but not least, a big thank you to Sonja Scheurer, who is available at all times of the day (and night) to discuss questions, problems and everything to do with judging with me and provide me with help and advice. Many an evening on show weekends and days and phone calls afterwards have been spent debriefing and discussing and I really appreciate the opportunity to share my thoughts and questions that have arisen and to get initial feedback on my ideas.

And of course I would also like to say a big thank you to all the judges for your commitment last year at all the DDI's dogdance tournaments and your active participation in the training courses. Without your willingness to support the tournaments and organisers with your time and know-how, it would not be possible to hold tournaments!

I am looking forward to the coming dogdance year and hope to meet as many of you as possible live at a tournament.

#### **TOP 9 Proposals of the members**

#### TOP 9.1 Change the number of HTM positions (Nina Neumann)

I propose to change the HTM positions to the 10 internationally valid positions.

This would be a relief especially for starters who compete at international tournaments or in other associations. As well as for starters who want to start in the DDI from other associations.

Most of the 8 additional positions in the DDI are very rarely shown. An exciting and balanced HTM choreo can be performed with the 10 internationally recognised positions. Furthermore, the 8 additional positions are not positions in the sense that the dog orients itself with its shoulder to the leg of the human. As it should be according to the definition.

They can still be part of a choreo as a trick.

# TOP 9.2 Submit tournament dates for the National Open and OEC Qualifiers by 30 June of the previous year (Board)

We would like to set the deadline for National Open and OEC qualification applications to 30 June of the previous year. This would give starters and organisers better planning security. Many organisers have to plan in advance, especially for such important tournaments.

Applications should therefore be received by the board by 30 June of the previous year.

An approximate time frame with circumstances (trade fair tournament, etc.) would also be sufficient if it is not yet possible to plan more precisely.

#### TOP 9.3 Increase in price of licence booklet if its lost (Board)

We propose to increase the price for lost licences. Up to now, a new licence booklet costs 10 euros. We would like to increase the price to the amount of a new licence booklet. The effort and costs for a replacement booklet are just as high as for a new licence, so why should a replacement licence be cheaper? Members receive the first booklet free of charge, if its lost, members must also pay the price of a new licence.

As there are discussions every year, we would like to put it in writing that only starters from classes HTM3 and FS3 will be admitted to the OEC qualification. If not enough class 3 starters take part in the qualification, no complete team can be sent. It is not possible to "fill up" from the HTM2 and FS2 classes.

#### TOP 9.6 Senior & Handicap-Classes (Claudia Moser)

I hereby propose to combine the two separate Senior-Handicap-Classes FS and HTM into one combined Senior-Handicap-Class.

If this proposal is accepted, this will also mean, that there will still be a record booklet needed to enter in this class, but it is not defined, if the competitor has a HTM- or a FS-record booklet.

Reason: In the Senior-Handicap-classes we usually only have a few competitors. Splitting those few competitors into two separate classes makes each class even smaller.

This makes it more cost intensive for the organiser (trophys and prizes) and at the same time it is less attractive for the competitors to enter really small classes.

As the judging-points for Senior-Handicap-Classes had been adapted (no points given for content and difficulty) there will be no problems when judging them in the combined class.

There is also no further problem with regard to the package regulation, as it is no longer possible to return to the other official classes of the division for which the licence booklet was submitted after a first start in the senior handicap class.

#### **TOP 9.9 Defintion Targets (Uta Opel)**

Clearly state under 6.3.2. that only target rods and floor targets as a pure training aid in their original condition lead to disqualification.

Reason: There are often discussions about whether it is a target or a prop. We all know that any prop can be used as a target. Some are more similar to commercial targets (e.g. walking stick with knob and others less so). Of course, it also depends on the way a prop is used.

Maybe there is a better term than "in original condition", but you know what I mean, what I mean...

One more thought: sometimes judges take a negative view if a prop is only used once in the choreography. However, it can fit in with the choreography that a prop is only used once. I have also found no indication in the regulations that a prop should be used more than once.

Granting of a 5% discount on the total transfer of membership fees of Swiss members who are members of GDS and therefore also members of DDI; the discount amount will be deducted directly by the GDS treasurer. GDS handles all the organisation itself via the association software.

Our written request dated 13 September 2013 could not be decided by the DDI Board, which is why we are submitting the request for a vote at the DDI AGM.

#### Background:

The board GDS (Gemeinschaft Dogdance Schweiz) has sent a letter to the board of the DDI (Dogdance International) on 13.9.23 in the context of the membership fee increase from Euro 20 to Euro 30.

We have asked them to grant us a discount of 5% on the total transfer of membership fees. This amounts to approx. 70.00 - 100.00 euros per year, which we would credit to our association in Switzerland and could use for other opportunities such as workshop or tournament support or the AGM supporting programme. This currently amounts to 79 membership fees. Since 2015, GDS has been regularly transferring total payments from all GDS members, these are usually amounts between 1400-1500 euros per year since 2016 - 2023 (from 2024 it will be around 2160.00 euros)

#### Reasons for granting a discount:

- 1. guaranteed payment, as GDS bears the payment responsibility for its members and carries out reminders and debt collection for GDS members independently of DDI
- 2. collective transfer, less work with checks and reminders for the DDI treasurer
- 3. punctual receipt of payment as at 31 March xx by GDS

During the discussion, a 2.5% discount and the assumption of the complete organisation via the association software was agreed.

#### TOP 11a Junior class license booklet (Vinciane Vialettes)

I would like to put to the vote two amendments concerning the junior category.

Children are the future of our sport and I would very much like to encourage them as much as possible through these adjustments:

I think it's a shame that juniors can't keep track of their participation in the junior class in the workbook. I therefore propose that when a junior competes in the junior class, these results should be entered in the workbook starting from the end so as not to disrupt the order of his or her participation in the official class.

#### TOP 9.12 Entering bitches in heat (Claudia Moser/Jugdes board)

Bitches in heat can enter all competitions and are allowed in the venue of the competition. We expect all competitors to pay attention to each other, look ahead and be considerate and respectful with each other.

The bitch in heat must wear pants whenever they are near the ring, in the preparation area as well as in the ring. Wearing pants within the complete venue is recommended.

The bitch in heat will be competing at the end of the class they have entered (Funclasses and official classes). If a competitor does not report his bitch in heat, a disqualification may be given until the end of the competition day.

The head judge will discuss with the organiser, if there might be any restrictions (not much space, narrow corridors, etc.) as well as defining a possible rest area for the bitches in heat (ideally a bit separated from the rest areas of the other competitors).

Headjudge and organiser in consultation with the dog owner, try to find the best possible solutions for all competitors. This might mean, that if there is not enough space, it might not be possible to have rest areas for the competing teams in the venue itself.

The organiser informs the competitors, if a bitch in heat is present and where the rest area for these dogs is. If participation of bitches in heat is explicitly not allowed according to hall regulations or regulations of the venue, this must be published in the announcement of the competition. The venue regulations must be published for this rule to be valid. In that case, entering an intact bitch is at the owners risk.

If a competitor withdraws a start due to the bitch being in heat, he will not get a refund of his entry fees. The organiser can (but is not obliged to) offer an alternative Funstart.

This offer also applies to any owner of a male dog who withdraws his dog from a class due to a bitch in heat being present.

Reason: at the first tournaments of the year there were different interpretations of the previous version, especially when it came to the exact whereabouts of the bitch in heat and who has to decide what. For this reason, this passage was formulated more precisely.

## TOP 9.13 Expenditure for the homepage (Executive Board)

The homepage must be brought up to date. This will cost approx. 4000 euros. According to the statutes, the members must vote on costs over 2000 euros.

# TOP 9.14 Annual Starting authorisation starting licence for ....EUR for non-members (Sandra Schneider)

#### Justification:

The association is currently only financially supported by the members, although non-members benefit from the association to a similar extent (e.g. provision of the rules, judges and their extensive training and further education, tournament structures) in order to achieve a little more balance here, we have considered introducing an annual starting licence in addition to the one-off payment for the licence booklet.

Members receive this licence free of charge - after payment of the membership fee at the beginning of the year (licence valid until 31 March).

A starting licence, like the licence booklet, is only compulsory for official starts.

The licence is related to the person, not to the licence booklet (one licence must be purchased per person)

Depending on the budget, a sponsor key will be worked out so that the additional income benefits the tournament organisers.

Comment from Sandra Schneider to a query from Conny and Estelle Dénervaud:

A voluntary transition option for organizers is to issue licenses at the event and then give the money to the club.

#### TOP 9.15 Earlier registration deadline for members (voluntary for organisers) (Sandra Schneider)

#### Justification:

Membership in the DDI should become more attractive. For very popular and heavily attended tournaments, we would therefore like to have the option of an earlier entry deadline for members. As this often means additional work for the organisers, this should be done on a voluntary basis by the organisers. With the annual starting licence, it would be easy to confirm membership and this could then be proven when registering. This would give members the opportunity to register a week in advance for the "Antanzen im Westen", for example, and they might have to worry a little less about whether they can get one of the coveted starting places.

#### TOP 9.16 Judges' clothing (Sandra Schneider)

As there was some displeasure regarding the "dress code" for judges, this passage should be adapted and defined more precisely.

Judges will receive a voucher from Spreadshirt with each training and further training course after completing all modules, but only every 2 years, so that they can dress appropriately. If you do not wish to accept this sponsorship from the DDI, you can have your own clothing produced (print shop, plot yourself, etc.), we will be happy to provide the templates. After submitting the invoice, the 25 € sponsorship will be paid out.

If the voucher is not redeemed, the DDI must be informed so that these vouchers can be allocated elsewhere. This sponsorship money is available to the judges; if the voucher is not redeemed, the money remains with the Spreadshirt shop, which is not the point.

If a judge does not wish to wear judges' clothing at all, they are required to at least attach a name badge with the DDI logo to their clothing. The template for the name badge is provided by the DDI, the design (to be pinned on, sticker etc.) is left to the judge. As judges, we should be recognisable during the entire tournament if possible, so that starters have the opportunity to recognise us and address us if necessary.

#### TOP 9.17 Judges' committee (Sandra Schneider)

In order to speed up the flow of information, one person from the Executive Board and one person from the judges' administration should always sit on the committee. This can also be one person who fills both positions. No voting rights, but admitted to discussions.

It is only about a simpler exchange of information.

Vote: Should one person from the Executive Board and one person from the judges' administration sit on the judges' panel as a panellist? (14.01 Uhr)

77 votes from 81 registrations in the vote box

Yes: 43 votes
No: 8 votes
Abstain: 26 votes

The motion was adopted.

#### TOP 9.18 Addition to OEC qualification (Sandra Schneider)

If a team does not qualify for the OEC (cancellation, injury, disqualification...) but there is still a place available in the national team for the OEC, this team can still move up if it wishes. The prerequisite is a registration for qualification.

If teams do not qualify for the OEC (cancellation, injury, disqualification...) but there are still a corresponding <u>undisputed</u> number of spots available in the national team for the OEC, these teams can still move up if they wish. The prerequisite is a registration for qualification and fewer registrations for qualification than there are spots available in the national team.

#### Examples for a clairifcation:

- 4 teams registered for the qualification, 1 dis = the team can still participate at the OEC as a team
- 5 teams registered, 1 dis and one cacellation = no one can move up because a selection would have to be made as to who becomes a reserve starter
- If participation in the qualification is canceled and the starter also withdraws his willingness to participate in the OEC, this place can be filled again, e.g. in the event of cancellation or dis

#### Justification:

The OEC is a major event that cannot be financed if fewer and fewer teams are travelling. As the number of Class 3 starters is already regulated, we would like to avoid a situation where there are even fewer teams due to a snapshot of the qualification process.

However, if there are more teams than free places available, the national team cannot be filled for reasons of fairness to all qualifying starters.

In special cases, the board decides by vote.

#### TOP 19 New definition of "end of the dance" (Judges Board / Verena Verones)

The "end of the dance" is not defined precisely enough and can be interpreted in different ways. This concerns the passage under disqualifications point 6.3.3 of the DDI regulations.

Therefore, in order to clarify whether a disqualification must be pronounced, I would like to propose the following motion for a more precise wording "end of the dance"

Old:

After the end of the dance, the dog still deals with the prop, performs a trick with it, plays with it. with it.

#### My suggestion new:

After the end of the dance, the dog still deals with the prop, performs a trick with it, plays with it.

The end point of the dance is defined by the team's final position action or movement and does not have to coincide with the end of the music.

**Explanation using an example:** The music is finished, the team is too late, but they complete their planned choreography. In this part of the choreography, which is completed without music, it may be planned that the dog still has to retrieve something, e.g. a basket, a flower, a prop in short, which only then results in the finished final picture. However, if the end of the dance is defined as the end of the music, the retrieve would lead to a disqualification as the dog is still working on the prop. The new regulation would not justify a disqualification, but only a lower score in the choreography category ( = poorly planned structure). This view is also conveyed in the workshops for the judges.

For a further precise definition, we would like to pass the application on to the panel of judges

If the end point of the dance is to be redefined (14.42 Uhr)

78 votes from 81 registrations in the vote box

Yes: 62 votes
No: 12 votes
Abstain: 4 votes

The motion was adopted.

#### **Editorial changes**

#### **HTM-Deductions:**

On the judging sheet a box will be added which is named: Too much Freestyle. The judges make a cross there, if they feel the team has shown more than the allowed 25% of Freesyle content.

The deduction itself will be incorporated in Content. The rules are as follows:

0% HTM and 100% Freestyle —> The Team can reach a max. of 10 points in Content. 25% HTM and 75% Freestyle —> The Team can reach a max. of 15 points in Content. 50% HTM and 50 % Freestyle —> The Team can reach a max. of 20 points in Content. 75% or more HTM —> The Team can reach up to 25 points in Content.

Smaller oversteps—> 0,5 - 1 points of deduction in Content. Slightly bigger oversteps 1-5 points of deduction in Content.

The deductions are at the judges discression and are made by estimation = there is no timer used, etc.

## Attack of a dog – Definition

- 1. Dog jumps out of the ring
  - Disqualification
- 2. Dog jumps out of ring and attacks another dog
  - -Disqualification and exemption from competition. The Judges at table can see and decide if it is an attack or not.
- 3. Dog jumps into the ring Disturbance from outside
  - The team in the ring gets the option for a rerun right away or at the end of the class.
- 4. Dog jumps into the ring and attacks competing dog
  - Disqualification and exemption from the competition for the attacking dog. If the competing dog in the ring defends himself and in the course of that hurts the attacking dog, there is NO Disqualification, as it was not the competing dogs fault, that the situation was happening.
- 5. Dog jumps out of preparation ring and attacks another dog but there are no visible wounds
  - no Disqualification
- 6. Dog jumps out of preparation ring and attacks another dog with visible wounds (blood, scratch, bite marks) = Level 2 or higher on Bite Scale
  - Disqualification and exemption from the competition Decision about severity can be made by Bite-Scale

If a dog is exempt from the competition, it can remain in the venue of the competition, but it must be under control and on leash at all times!
